

## **LATA Grantee Monthly Contractor Reporting Form**

Public Utilities Code section 281(l)(1) requires all California Advanced Services Fund (CASF) grantees approved and funded on or after July 21, 2021, that use a licensed contractor or subcontractor undertaking a contract or subcontract in excess of \$25,000 to report monthly to the California Public Utilities Commission (Commission), at minimum, the name and contractor's license of each licensed contractor or subcontractor, the location, and anticipated dates of work to be performed.

## **Instructions**

Decision (D.) 22-02-026 cites the authority of Pub. Util. Code Section 281(b)(5)(A) to provide technical assistance to local governments. Therefore, LATA grantees approved and funded on or after July 21, 2021, must submit a monthly LATA Grantee Monthly Contractor Reporting Form for each licensed contractor or subcontractor undertaking a contract or subcontract in excess of \$25,000.
