**PUBLIC UTILITIES COMMISSION REPORT PURSUANT TO PUBLIC  
UTILITIES CODE SECTION 321.6****Introduction**

Pub. Util. Code Section 321.6 requires that the California Public Utilities Commission report on the number of formal proceedings where resolution exceeded the time periods prescribed in scoping memos and the number of days that Commissioners presided in hearings. It further requires that the Commission submit the report to the Governor and Legislature no later than February 1 of each year. As described in this report for calendar year 2011, all of the 246 proceedings resolved at the Commission during 2011 were timely. More detailed information is contained in attached Appendices A-J

Pub. Util. Code Sections 1701.1 et al. apply to cases filed after 1998 that were subject to hearing at the Commission. These statutes require that matters be resolved within certain time periods, depending on the categorization of a proceeding. Generally, adjudicatory matters must be resolved within 12 months and ratesetting and quasi-legislative matters are to be resolved within 18 months of the issuance of the scoping memo ruling. A proceeding has been resolved when the main issues have been decided such that the proceeding could usually be closed. At times, proceedings that have had all substantive issues decided may remain open or are "re-opened" because of other tangential issues, such as petitions for modifications, various motions, or requests for intervenor compensation.

In addition to data related to proceedings that were subject to hearings, this report contains important case management information on other proceedings.

**Description of Attached Appendices A-J****Appendix A – Formal Proceedings not Subject to Hearings, Active During this Reporting Period.**

Appendix A lists the 316 cases active during the time period that were not subject to the hearings. Many of these proceedings are ratesetting or adjudicatory matters that were conducted without formal evidentiary hearings. Also, this appendix lists 37 quasi-legislative matters that were processed through the exchange of written documents and formal evidentiary hearings were not required.

Of the 316 cases, 188 were resolved timely. The remaining 128 proceedings are currently active and on schedule.

### **Appendix B – Complaints Under the Expedited Complaint Procedure, Active During the Reporting Period.**

Appendix B lists 42 Expedited Complaint Proceedings (ECP) that are small complaint cases handled under special procedures analogous to “small claims” court. We are reporting these matters separately because the Commission has adopted more aggressive timelines for these cases than the legislative timelines. The Commission has established an informal 132-day target for this type of proceeding to be resolved.

During the reporting period, 25 of these 42 cases were resolved. All 25 resolved matters met the 12 months legislative mandate. Seventeen proceedings remain active.

### **Appendix C – Federal Telecommunications Arbitration Proceedings, Active During the Reporting Period.**

The Federal Telecommunications Act of 1996 created a new type of proceeding with aggressive timelines. These proceedings are not subject to the legislative timelines. During the reporting period, one arbitration proceeding was closed and there is no arbitration proceeding pending at the Commission.

### **Appendix D – Formal Proceedings Subject to Hearings, Active During the Reporting Period – Proceedings Resolved on Schedule.**

During the reporting period the Commission timely resolved 31 (22 ratesetting, 7 adjudicatory and 2 quasi-legislative) proceedings subject to the evidentiary hearings.

### **Appendix E – Formal Proceedings Subject to Hearing, Active During the Reporting Period – Proceedings not Resolved on Schedule.**

All formal proceedings subject to hearing resolved during the reporting period were timely. This is the second year since the reporting period was initiated in 1998, that the Commission has achieved 100% compliance with the legislative deadlines for proceeding resolution.

### **Appendix F – Formal Proceedings Subject to Hearing, Currently Active and on Schedule.**

Appendix F contains cases subject to hearing that are not yet resolved and currently still active. There are 167 such cases – 53 adjudicatory, 1 quasi-legislative and 113 ratesetting. All of these cases are currently on schedule.

### **Appendix G – Petitions for Rulemaking**

Petitions for Rulemaking are statutorily mandated type of proceeding not subject to the SB 960 guidelines in Pub. Util. Code Sections 1701.1 et al. The Commission is mandated to issue a decision in this type of proceeding within six months. Appendix G shows that three such proceedings were active during the reporting period, and that the Commission has issued timely final decisions in one of the proceedings. The remaining two proceedings are on schedule.

### **Appendix H – Commissioner Attendance**

Appendix H reports the Commissioner attendance at hearings during the period. The table shows that Commissioners attended 52 days of hearings and presided during 16 of those 52 days.

### **Appendix I – 60-90 Day Compliance**

The Legislature has also established guidelines for the length of time between the issuance of a proposed decision and the adoption of a final decision by the Commission, applicable to ratesetting and quasi-legislative proceedings requiring a hearing. The guidelines are either 60 or 90 days depending on certain circumstances.

During the period, the Commission considered 26 proposed decisions in proceedings subject to these guidelines. The Commission adopted 19 final decisions in such proceedings. In 12 instances the final decision was adopted within the guidelines and in 7 instances the final decision was issued later than the period specified in the guidelines. Six proposed decisions are currently on the Commission's Agenda and one proposed decision was withdrawn from consideration.

### **Appendix J – Issuance of Presiding Officer Decisions and Proposed Decisions**

For proceedings that require a hearing, the Legislature has also established guidelines for the length of time between the submission of a matter for decision and the issuance of the proposed decision. During the period, the Commission issued 9 presiding officer decisions and 19 proposed decisions in such proceedings. Out of these 28 decisions, 17 (61%) were issued within the mandatory 60- and 90-day timelines. We will continue to strive for improvement in this area.

### **Conclusion**

In summary, 560 proceedings were active at the Commission during the 2011 reporting period. All of the 246 proceedings resolved during 2011 were timely. This is the second time, since the reporting periods were initiated in 1998, that the Commission achieved 100% compliance with the deadlines for proceeding resolution. The Commission is committed to comply with the Legislative timelines.
