Dear Mr. Schwecke:

The Safety and Enforcement Division (SED) of the California Public Utilities Commission (CPUC) conducted a General Order (G.O.) 112-F Comprehensive Operations and Maintenance Inspection at San Diego Gas and Electric (SDG&E's) Moreno Valley Compressor Station on February 7, 2022.

The inspection included a review of the Station's Leak Survey, Patrol, Cathodic Protection, Valves, Overpressure protection (reliefs and shutdowns valves), Emergency Shut Down (ESD) system, Gas Detection and Alarm systems inspection records for calendar years 2018 through 2021 and field inspections of the facilities. In addition, SED's staff reviewed Operator Qualification records, which included field observation of randomly selected individuals performing covered tasks.

SED staff used the Pipeline and Hazardous Materials Safety Administration's (PHMSA) Inspection Assistance (IA) as a reference guide to conduct this inspection. SED's staff did not observe any probable violations of G.O. 112<sup>1</sup>, Reference Title 49 Code of Federal Regulations (CFR), Part 192 during this inspection. See attached Post-Inspection Written Preliminary Findings.

Since there were no violations/concerns, the audit is therefore closed.
