Dear Mr. Schmitz:

The Safety and Enforcement Division (SED) of the California Public Utilities Commission conducted a G.O. 112-F review and inspection of Southwest Gas Company's (SWG) updates to its Operation and Maintenance (O&M) Procedures and Emergency Response (ER) Programs on January 4-8, 2021. SED staff reviewed SWG's written O&M and ER procedures pursuant to G.O. 112-F, Reference Title 49, Code of Federal Regulations (CFR), Parts 191 and 192 and used Pipeline and Hazardous Material Safety Administration's (PHMSA) Inspection Assistant (IA) as a reference guide to conduct the inspection. SED staff reviewed records remotely during this inspection due to COVID-19 shelter-in-place orders and social distancing guidelines.

SED staff found no probable violations or concerns during its inspection and considers this inspection closed.
