**EXECUTIVE SUMMARY**

---

As previously reported, NRG Energy, Inc. (NRG) continues to execute its obligations under the Agreement through EVgo Services LLC (EVgo).

As of June 5, 2017 (the Reporting Date), EVgo had a total of 181 Freedom Station sites either constructed or under development. During the Reporting Period, EVgo completed construction on 5 additional Freedom Station installations, for a total of 171 completed sites.

35 out of the 171 Freedom Station sites (20 percent) are located in qualified low-income areas (PUMAs), meeting the 20% commitment, and serving a broad demographic range at places they prefer to shop, meet and play locally, such as grocery stores, shopping centers and malls.

Freedom Stations are open for any electric vehicle and offer multiple forms of payment, including credit card. All stations support both the CHAdeMO and SAE CCS fast charging standards.

Utilization of the public charging infrastructure continues to increase. 168,908 fast charging sessions were reported in the quarter. Together, these sessions delivered 1,869,616 kWh of electricity.

Overall, EVgo has 731 Make-Readies Sites under contract, representing 6,319 Make-Ready Stubs. Of these, 4,712 Make-Ready Stubs have been installed at 547 sites. 781 of these Make-Ready Stubs at 92 sites were installed in the previous quarter.

All Technology Demonstration funds have been allocated, and the three projects are underway. Both EV Opportunity programs were approved by CPUC staff in early 2017. Specific updates for all five projects are provided below.

**SECOND AMENDMENT**

---

As reported in the 2016 Annual Report, on February 22, 2017, NRG and the CPUC entered into a Second Amendment to the Agreement. The principal changes set forth in the Second Amendment are as follows:

- Extended the operating period commitment for the Freedom Stations to December 5, 2020.

- Allocated up to \$12.5M of the \$40M Make-Readies Amount for NRG/EVgo to build at least 10 “Charging Plazas”.
  - Charging Plazas consist of at least 3 DC Fast Chargers with the potential for larger and higher-power chargers.
  - These Charging Plazas will be located in areas with higher concentrations of multi-family dwelling residents and meet other siting and distribution requirements.
  - Charging Plazas must stay operational through at least December 5, 2020.
  - The amount spent on Charging Plazas reduces the Make-Ready Stubs requirement at \$4,000 per stub.
- The Make-Ready Stubs Installation Period was extended through December 5, 2018.
- The Multi-Family Housing minimum requirement for Make-Ready Stub deployment was eliminated.
- Energy storage is now permitted equipment at Freedom Stations and Charging Plazas, and up to \$2.5M of the above-referenced \$12.5M can be utilized for adding energy storage to retrofit existing Freedom Stations.
- Price cap for single-use walk-up pricing at Freedom Stations was increased to \$15; for Charging Plaza fast-chargers greater than 50kW, the price cap for single-use walk-up charging is \$25.

Details regarding installation of Charging Plazas will be included as implementation proceeds.

#### **INSTALLATION OF PUBLIC EV CHARGING STATIONS (FREEDOM STATIONS)**

---

As of the Reporting Date, a total of 181 Freedom Station sites were either completed, under construction, or in the permitting process.

The table below summarizes Freedom Station progress throughout the term of the Agreement:

### *Installations*

During the Reporting Period, EVgo completed construction on 5 additional Freedom Stations, for a total of 171 Freedom Stations. Completed Freedom Stations are listed in Appendix A, with new stations **in bold**.

The Agreement requires a minimum number of Freedom Stations in each of four geographic regions. The table below summarizes the geographic distribution requirements and progress as of the Reporting Date.

As seen in the preceding table, the Minimum Freedom Station Count has been fully met or exceeded in the SF Bay Area and the San Joaquin Valley. Current exceedances will contribute to meeting requirements of the anticipated Freedom Station Savings event, as noted below.

### *Site Development*

As of the Reporting Date, 3 additional Freedom Station sites were under construction, 4 more were fully permitted and another 3 sites had been submitted for permitting.

Based on current projections, EVgo anticipates having a Freedom Station Savings Event (as such term is defined in the Agreement), and has begun site planning, development, construction and operation of additional Freedom Station sites and/or expanded capacity as required.

### *Low-Income PUMA Distribution*

Thirty-five of the 171 Freedom Stations are located in low-income PUMAs: 15 in the San Francisco Bay Area, 12 in the Los Angeles Basin, 4 in San Diego County, and 4 in the San Joaquin Valley. They represent 20.5% of all operational sites, meeting the goal of 20% in this category.

Assessing Freedom Station distribution by income classification of PUMAs is a device that CPUC and NRG developed for the settlement agreement because no other standards existed at the time. Since then, the Office of Environmental Health Hazard Assessment (OEHHA), on behalf of the California Environmental Protection Agency (CalEPA), developed the California Communities Environmental Health Screening Tool. CalEnviroScreen is a screening methodology that can be used to help identify California communities that are disproportionately burdened by multiple sources of pollution. CalEPA has used the tool to designate California communities as disadvantaged pursuant to Senate Bill 535.

Applying CalEnviroScreen to the Freedom Station distribution for information purposes, as requested by CPUC, shows nearly the same number of qualifying sites (36 out of 171), but with a slightly different distribution than the PUMA communities. The results are presented in the table below. NRG and EVgo will continue to assess the distribution by this standard in coming reports to align the state’s environmental justice standards with the settlement infrastructure.

*SAE Combo Rollout Complete*

All Freedom Stations support both the SAE combo (CCS) and the CHAdeMo connector standards. This fleet of CCS chargers represents the largest known deployment in the world.

*Credit Card Payment Upgrades Complete*

All Freedom Stations and all chargers at Freedom Stations are able to accept credit cards via a swipe-card reader. Additional payment mechanisms include RFID cards for EVgo, EZ Charge, BMW ChargeNow, Kia Charge Up. EZ Charge and Kia Charge Up cards are compatible with chargers networked by EVgo, Greenlots, Blink and AeroVironment. BMW ChargeNow cards also access chargers networked by Chargepoint. Additionally, all EVgo stations are accessible via phone center with customer service phone numbers printed on the stations.

**INSTALLATION OF MAKE READY STUBS AND MAKE READY ARRAYS**

---

*Status of Make-Readies Sites*

Overall, EVgo has 731 Make-Readies Sites under contract, representing 6,319 Make-Ready Stubs. Of these, 4,712 Make-Ready Stubs have been installed at 547 sites, as set forth in Appendix B.

NRG and EVgo have had particular success reaching disadvantaged communities with this program. For information purposes, CPUC staff requested an analysis of distribution based on the Cal Enviro Screen (CES) standard, which did not exist at the time the settlement was enacted. The distribution is reported in the chart below.

Another way to consider make-readies distribution to disadvantaged communities or residents is to consider the percentage of multi-dwelling unit (MDU) properties (and stubs) that have deed-restricted housing units. By this standard, the results look more beneficial at 29% of total operational MDU stubs. This is due in part to inclusionary housing requirements in many California communities, where mixed-income housing in single properties is a norm. Thus, residents of low-income housing units as measured by the median income in the region have reasonable access to the stubs built in this program.

## USAGE DATA

---

EVgo completed 168,908 fast-charging sessions in the Reporting Period at Freedom Station sites and dispensed over 1,869,616 kilowatt-hours of electricity.

This translates to 5.8 million miles driven on electricity in this quarter, displacing 240,434 gallons of gasoline (assuming 3.125 miles per kWh and 24.3 mpg).<sup>2</sup>

## TECHNOLOGY DEMONSTRATION PROGRAMS

---

### Stationary Storage Plus Electric Charging (SSPEC)

#### *Project Summary*

The Stationary Storage Plus Electric Charging (SSPEC) project is investigating how incorporating stationary batteries with DC fast chargers (DCFC) electric vehicle (EV) charging infrastructure can reduce the cost of developing, constructing, and operating public fast chargers without the use of incentives. The project is doing this by:

1. Deploying a test site with microgrid components, including battery storage, solar generation, EV charging infrastructure, and site control technology.
2. Running a number of tests with various configurations of devices at the SSPEC Site.
3. Analyzing results from the SSPEC Site and historical data from EVgo's charging station network to identify load profiles, deployment sites, and utility territories which can benefit most from backup batteries and/or generation on site.

Upon successful economic and operational demonstration, EVgo intends to commercialize these technologies and integrate them into its broader Freedom Station network. Ultimately, EVgo believes that the SSPEC work will enable faster deployment of DC fast chargers by EVgo and third parties at a wider variety of locations. Moreover, these stations will have a lower total cost of ownership to property owners and electric vehicle service providers (EVSPs) alike.

#### *Previous Quarter Activities*

- The operation of the SSPEC Site continues to be refined:
  - The site controller continues to actively monitor meter demand and dispatch the batteries to reduce peak load.
  - The firmware on the BTC charging stations continues to be upgraded.

- The automatic load management system (ALMS) has been tripping sporadically due to it being rated at 160 amps. A request to remove this system will be submitted to UCSD in the near future:
  - This ALMS system was originally installed to explore the possibilities of sharing power between multiple chargers, which can now be accomplished by the individual chargers so it is no longer needed.
  - Removing the ALMS will maximize uptime and reduce maintenance trips to the site.
  - At any given time, two of the four BTC dispensers are deactivated for activities including firmware updates, further reducing the risk of tripping the ALMS. The chargers will be reactivated in phases once the ALMS has been removed.
- Progress is continuing towards installing batteries at commercial stations:
  - EVgo has identified two operational Freedom Station sites to install battery storage at, one in Santee (near San Diego) and one in Union City (in the Bay Area)
    - The Union City site has replaced a site in Mission Viejo due to local traffic considerations and for the opportunity to install a battery system in two different utility territories (San Diego Gas and Electric and Pacific Gas and Electric).
    - The permitting for the battery is complete for both of these sites.
    - The utility interconnection application for both of these sites is in progress.
- Kisensum produced the Stationary Storage Plus Electric Charging (SSPEC) controller report, detailing the controller's functionalities, including managing complex sites with batteries and chargers at multiple charging levels. EVgo will leverage this report in the implementation of both Phase III SSPEC sites and future EVgo sites with battery storage (report attached in Appendix D-1 as Appendix A).

#### *Subsequent Quarter Activities*

- Continue to improve the reliability of the SSPEC Site:
  - The ALMS will be removed to reduce the sensitivity in the SSPEC Site circuit, pending approval from UCSD.
  - A local area network (LAN) communication system will be installed to reduce variability in the communication system. The site components currently communicate wirelessly.
- Install two battery systems in commercial charging locations (Phase III):
  - This will include finishing the utility interconnection applications, construction and local site controller calibration.
- The next quarterly submission will include a report by a UCSD PhD student outlining research findings about the requirements to install second life batteries in a few of the California utilities.

## **EV Storage Accelerator (EVSA)**

### *Project Summary*

The EV Storage Accelerator (EVSA) aims to demonstrate vehicle-to-grid (V2G) technology as a low cost energy storage resource. The project will use nine vehicles for the demonstration, three Honda Accord Plug-in Hybrid electric vehicles (PHEV) and six Nissan LEAF Plug-in electric vehicles (PEV). The four primary goals of EVSA are:

- Create a test environment for two major automakers, Nissan and Honda, to gain experience with V2G technologies and prepare them for a further commitment to the technology,
- Advance product readiness for bidirectional inverters, including listing standards and product certification
- Identify use cases for V2G and test vehicles against those use cases.
- Inform public policy around the system, ratepayer and customer benefits of V2G.

### *Previous Quarter Activities*

All six Princeton Power CA-10 stations received final UCSD inspection and were commissioned by Princeton Power as of the end of Q2 2017. The stations have required frequent trouble shooting as the project drivers have started to use them daily. Only five the six stations installed are currently being used by drivers. The sixth station, which is outside of UCSD's micro-grid and on SDG&E's grid at the Trade Street location, awaits UL-field listing of the inverter inside the CA-10 unit. Once the field listing is complete, the interconnection application can be processed and the station can gain approval from SDG&E to operate as a bi-directional charger.

During Q2 2017, the five drivers assigned to the Nissan LEAFs signed a leasing agreement with EVgo, completed a motor vehicle background check and completed the project's driver on-boarding. The drivers are overall satisfied with their vehicles, but remain concerned with the initial lack of reliability of the charging stations. The project team is in the process of negotiating a more robust service and maintenance agreement with Princeton Power to ensure minimal down time.

The project team finalized an agreement with Honda Motors to use three bi-directional Honda Accord PHEVs in the EVSA project during Q2 2017. One of the three bi-directional Honda Accord PHEVs was assigned to a driver at UCSD. Use of the other two Honda Accord PHEVs by the EVSA project must await the results of additional testing being conducted by Honda at NREL and TUV Rheinland Japan.

The project team continued to make progress on solidifying the project use cases to be executed, as required by the CPUC. In Q2 the project team also met with the CPUC Transportation Electrification team to update them on project progress and discuss editing the initial project scope of work. The CPUC team gave a tentative verbal approval of the changes proposed by the project team and official approval is pending following CPUC internal processes.

Finally, EVgo brought on Nuvve in an official sub-contractor capacity to assist in managing the day to day on the ground operations of the project. Nuvve will maintain close contact with EVgo regarding all project budget and asset decisions.

### *Subsequent Quarter Activities*

All Princeton Power stations will receive UL-field listing, including Trade Street. Trade Street's interconnection application will be approved by SDG&E. The sixth and final Nissan LEAF driver will be identified and assigned to the Trade Street location. All stations will be connected to the Nuvve aggregator server and data collection will commence regarding charging sessions.

The project team will start to actively work with stakeholders to start executing the identified use cases (Interconnection, Transformer Upgrade Deferral, Emergency Back-up Power, and Value of V2G). The project team will also start to execute on some of the deliverable reports required by the CPUC under the project scope of work.

## **Extreme High Power DC Charging Station**

### *Project Summary*

Automakers are continuing to increase range of EVs by increasing battery, as evidenced by the late-2016 release of the all-electric Chevy Bolt with 238 miles of range. To maintain a consistent customer/EV driver experience regarding charge duration and SOC (State of Charge) completion percentage, DC EVSE infrastructure must increase the power dispensing. This project is intended to bring auto OEMs, EVSE, and cable manufacturers together to demonstrate and facilitate testing and development of standards and equipment. The project will do the following:

- Deploy first of its kind EVSE infrastructure capable of high power (300 + amps) of VDC power to EVSEs on site.
- Test with auto OEMs and EVSE providers to allow for test bed and development of standards.

### *Current Quarter Activities*

EVgo conducted the preliminary site walk for the Baker Super Station in May 2017. Several bidding contractors and the site host were in attendance and discussed project logistics and site mobilization. At present, EVgo has obtained utility approval of design and engineering. Final building and safety revisions have been submitted to the AHJ for approval with approved construction permits ready to issue as soon as the end of June. Offsite fabrication of the solar canopy has commenced and is on schedule. EVgo has received all contractor bid proposals and is in final bid qualification review. Contract winners will be notified by the end of this month, with construction tentative to commence the first week of July.

## **EV OPPORTUNITY PROJECTS**

---

The EV Opportunity Program under the Agreement consists of \$4 million toward “...Enhancing the appreciation of the social benefits of electric vehicles and creating opportunities for residents of under-served communities to benefit from expanded use of electric vehicles.” More specifically, the EV Opportunity Program Amount may be used to fund: a) the deployment of electric vehicle charging infrastructure to support electric vehicle car-sharing projects, in particular in low-income areas within the State of California, b) an EV job training program and c) other projects consistent with the objectives of Section 4(d)(ii) of the Agreement.

In Q1 2017, two Opportunity Program project proposals that EVgo submitted for the CPUC’s review were approved: Green Raiteros and Electric Access Charging Hub (EACH). In Q2 2017, EVgo began preparing for the Q3 2017 Green Raiteros project kick-off and completed the EACH project kick-off.

### **Green Raiteros**

The Green Raiteros Pilot Project will be executed in partnership with the San Joaquin Valley Latino Environmental Advancement Project (Valley LEAP) and the Fresno County Rural Transit Authority (FCRTA), the Shared Use Mobility Center (SUMC), and West Hills Community College. The Green Raiteros Pilot will build on an existing, grassroots ridesharing program – the Raiteros – and will help expand access to carbon-free mobility in the Central Valley by strategically and sustainably introducing EVs to the Raiteros’ services. EVgo also worked with Valley LEAP to apply for the 11th Hour Project Just Transit Challenge, a fund dedicated to reduce emissions while increasing equitable transportation options. This funding was awarded and will be used to acquire two 2017 Chevy Bolt’s for the Green Raiteros Pilot Program.

In preparation for project kick-off, EVgo has scheduled preliminary site assessments for the Huron and West Hills College infrastructure deployments. EVgo, SUMC and Valley LEAP have begun outlining the detailed scope for Business Model Development and Capacity Development activities.

### **EACH**

The main focus of the Electric Access Charging Hub (EACH) project is to create EV access and job opportunities to underserved communities. EVgo will develop seven EV-charging hubs in low-income communities of the San Francisco Bay Area, Los Angeles, and San Diego that will serve the public as well as electric carshare vehicles. The EACH project aims to support EV carsharing, create job opportunities, provide publicly available EV fast charging, and spur the adoption of electric vehicles in underserved neighborhoods.

In Q2 2017, EVgo conducted an internal kick-off meeting and began site development and preliminary partnership discussions with entities including: the city of San Francisco, the city of Oakland, the city of Richmond, Los Angeles Department of Transportation, Los Angeles County Metropolitan Transportation Authority, and Grid Alternatives. Several additional communities have begun expressing interest in public-private partnerships around ridesourcing applications

that serve disadvantaged communities. SUMC will conduct interviews in Q3 2017 to further evaluate the potential for these partnerships.
