5. All records with respect to the well identified as API No. 03700776 operated by Southern California Gas Company in the Aliso Canyon Oil/Gas Field, Well No. 25, Lease Name: Standard Sesnon, including all inspection reports.
6. All documents regarding any and all complaints of any type whatsoever with respect to noxious odors, fumes, gas smells, or other olfactory complaints in or around the neighborhood of Porter Ranch in the County of Los Angeles, State of California.
